



BY-LAWS OF ACBL UNIT 430, VANCOUVER, B.C.

The Unit functions within the By-laws and Regulations of the American Contract Bridge League and its District.

The objects of the organization are:

- (a) To preserve and promote the best interests of and to stimulate interest in the art of playing competitive duplicate contract bridge and any modifications thereof;
- (b) To cooperate with, and assist the League in the promotion and conduct of contract bridge tournaments;
- (c) To encourage the highest standards of conduct and ethics by its members, and to enforce such standards;
- (d) To promote the development and organization of affiliated clubs within the Unit;
- (e) To cooperate in the League's charity programs, and to sponsor and conduct charity events with the object of realizing funds to be devoted to worthy humanitarian causes;
- (f) To conduct such other activities as may be in keeping with its principal objectives.

ARTICLE 1 - UNIT JURISDICTION

The geographical area within which this Unit shall have jurisdiction shall be such area as is presently or may in the future be assigned to it by the Board of Directors of the ACBL.

ARTICLE II - MEMBERSHIP

- A Any person of good moral character and residing within the jurisdiction of the Unit, subject to District regulations, is eligible for membership, and no person shall be denied membership because of race, creed or color.
- B Such person, upon favourable action, shall become and remain a member unless:
- (1) He changes his residence to a place outside the jurisdiction of the Unit, in which case he shall become a member of the new Unit immediately on processing by the League of his change of address;
- (2) He has failed to pay his dues in accordance with regulations of the American Contract Bridge League;
- (3) He has been suspended or expelled from membership in accordance with regulations established by the American Contract Bridge League and the Board of Directors of the Unit, provided, however, that such regulations shall conform to the rules of due process applicable to membership corporations, and that such regulations as are established by the Board of Directors of the Unit shall not be in conflict with the regulations of the American Contract Bridge League.
- C Membership in the Unit carries with it membership in the American Contract Bridge League.

ARTICLE III - DUES

A - Annual dues shall be in the amount fixed by the ACBL.

ARTICLE IV - MEMBERSHIP MEETINGS

- A There shall be an annual meeting of the members, which may be held in connection with a tournament or special event which Unit members attend.
- B The Unit Board of Directors shall fix the time and place of the annual meeting and shall give appropriate notice by mail of such meeting.
- C Special meetings of the members may be called at any time to consider specific subject matters by the Unit Board of Directors or by the President or by a petition signed by fifty (50) of the members and submitted to the Unit President or Secretary. Notice of the time and place of any special meeting shall be given by mail at least ten (10) days before such meeting. The notice of any special meeting shall contain an Agenda of the matters to be taken up at such meeting. No other business shall be acted upon at such special meeting.
- ${\sf D}$ A quorum for the transaction of business at any annual or special meeting shall consist of fifty (50) members.
- E No proxies shall be permitted.

ARTICLE V - UNIT BOARD OF DIRECTORS

- A $\underbrace{\text{Number of Directors}}$: The affairs of the Unit shall be managed and conducted by the Unit Board of Directors which shall consist of twelve elected persons and, on occasion (as per Section B below) the President from the previous term. All Directors must be members of the Unit.
- B Term of Office: Each year six Directors shall be elected for a two year term beginning July 1st. The Director who served as President just prior to the expiry of his term of office shall, without election, serve the following year as past-President unless he/she chooses to run for a new two year term on the Board. All elected Directors shall hold office until their successors have been duly elected.

- C Nomination of Directors: The Board of Directors, at least sixty (60) days prior to the Annual membership meeting, shall select a Nominating Committee, composed of at least three active persons, a majority of whom shall not be members of the current Board of Directors. Any member other than the nominating committee may send the name of a person or persons with written consent of the nominee(s) to the Chairman of the Nominating Committee by June 1st. The Nominating Committee shall prepare a slate of nominees to be mailed to the members at least twenty-one (21) days before the Annual Meeting unless the number of nominees does not exceed the number of vacancies in which case those nominees shall be deemed to be elected. Club owners and Unit employees are ineligible for nomination to the Board.
- D Election of Directors: To qualify as a voting member at the annual election, members must be included in the League's April computer listing of Vancouver Unit members. Every qualified member shall be entitled to one vote for each director to be elected. Voting shall be by mail. The ballots shall be secret and must be received by June 30th. All candidates are entitled to have witnesses at the counting.
- E-Vacancies: Any vacancy on the Unit Board of Directors shall be filled by the Board of Directors and the person so appointed shall hold office for the balance of the fiscal year.
- F Meetings: The Unit Board of Directors shall hold a minimum of ten (10) meetings a year.
- G Quorum: Seven directors shall constitute a quorum at Board Meetings.
- H Powers and Duties: In addition to the powers herein granted by other provisions hereof, and by the laws of the Province of British Columbia, the Unit Board of Directors shall have powers and duties including but not limited to:
 - The conduct, management, supervision and control of the business and assets of the Unit;
 - (2) Conduct of Unit tournaments;
 - (3) The employment and discharging of employees, and the supervision of their conduct and fixing of their compensation.
- I Board Membership: The Unit Board of Directors shall be the sole judge of its membership.

ARTICLE VI - UNIT OFFICERS

- A <u>Number</u>: The officers of the Unit shall consist of a President (whose term of office shall not exceed two consecutive years), a Vice President, a Secretary and a Treasurer.
- B Election of Unit Officers: The Unit Board of Directors shall elect all officers at its first meeting following the annual membership meeting, and the persons elected shall hold office for one year or until their successors have been duly elected.
- C-Vacancies: Vacancies due to death, resignation or other cause shall be filled by the Unit Board of Directors.
- D \underline{Duties} : The duties of the officers shall be those that ordinarily pertain to their respective offices and such others as may be assigned by the Unit Board of Directors.

ARTICLE VII - IMPEACHMENT

Any director may be removed for cause from any meeting of the Unit Board of Directors provided two-thirds of those present (and consisting of at least seven (7) members) shall so vote. Any directors against whom impeachment charges shall be brought shall be notified in writing, by registered mail, of charges against him, at least ten (10) days prior to the meeting and shall be given an opportunity to be heard before the Unit Board of Directors and to be represented by counsel of his own choosing. Absence from three consecutive meetings may be cause for removal of a director.

ARTICLE VIII - COMMITTEES

The President shall appoint such committees as may be necessary to perform the functions of the organization. Standing committees shall be appointed with the approval of the Unit Board of Directors.

ARTICLE IX - DISCIPLINARY ACTIONS

A unanimous vote of the Directors present is required for expulsion of a member and a two-thirds majority of the Directors present for any other disciplinary action.

ARTICLE X - UNIT REGULATIONS

The Unit Board shall establish regulations for the proper management of Unit affairs. These regulations will be in accordance with the By-laws of the ACBL and of this Unit. They will be made known to the membership. Regulations may be altered from time to time by the Unit Board by a vote of seven or more of the directors.

ARTICLE XI - AMENDMENTS TO THE BY-LAWS

Amendment to the By-Laws may be made by the members of the Unit upon petition signed by at least fifty (50) members and submitted to the Secretary at least sixty (60) days in advance of the annual meeting or any special meeting called for the purpose or upon petition signed by at least seven (7) members of the Unit Board of Directors. It shall by the duty of the Secretary to incorporate the text of the proposed amendment in the notice of the meeting. The concurrence of two-thirds of all members present and voting

Six positions need to be filled to replace the six outgoing directors. The term of office si two years with the directors expected to attend monthly meeting in addition to some committee work.

Any Unit 430 member may put forward a nominee, so long as the nomination along with the written consent of the nominee(s) to Chairman Hy Waks before June 11, 1976.

The only restrictions are that nominees must not be club owners or unit employees.

New members are eligible to vote if they have been a member for at least two months.



UNIT 430 ACBL ANNUAL MEETING

The annual general meeting of the Vancouver, B.C. Unit was held at 7:00 p.m. at the Holiday Inn on Howe on July 11, 1976. More than 50 members present. Ted Trites, retiring President was in the chair.

The minutes from the last general meeting were read by Donna McDuff. It was moved and seconded that the minutes be adopted as read. Passed.

Ted gave the President's report. The Board held 12 meetings during the past year; no important problems arose; attendance at the Board meetings dropped off somewhat. Ted outlined the duties of the Board members during the past year and complimented them on doing a fine job. He also thanked the 100 & E committee and the election committee.

Bob Currie gave the Treasurer's report. As of June 30, we had \$973.93 in the current account, accounts receivable of \$36.00, and outstanding cheques of \$1,341.00, for a balance of \$351.54. The membership account has \$1,175.20, with \$192.50 outstanding, for a balance of \$982.70. The special funds account has a balance of \$967.21. Cut net overall balance is \$1,598.37. It was moved by Bob Currie and seconded by Jo. MacDonald that the Treasurer's report be adopted as read. Passed.

The By-laws were next on the agenda. After a short discussion, it was moved by Henry Smilie and seconded by Bob Brooks that the new constitution be adopted. Passed.

Election results - the following were the successful candidates from the election to the Board for the following term: Bill Worsfold, Charlie Swanson, Pat Stevens, Margret Von Schulmann, Jo MacDonald and Jane Green. Thanks to all who ran and congratulations to those elected.

Lawrence Betts inquired about the number of spoiled ballots in the election. It was reported that there were 259 identified unusable ones and the not identified unusable ones.

Brian May inquired as to the exact nature of a "Unit employee". For the purpose of the By-laws, this is deemed to be only the Unit Game director(s), Mrs. Ginn and Phil Wood.

The meeting was adjourned.

PRESIDENT'S ANNUAL REPORT: July 11, 1976

Your Board of Directors met twelve times in the past year and we have discussed the usual wide range of matters that are concened with the operation of duplicate bridge in the Vancouver area. I am happy to report that there are no important problems outstanding and, in fact, there there have been no truly outstanding problems during the year. Attendance at Board meetings has dropped off somewhat during the year. We were never without a quorim but I would like to take this opportunity to remind present and future Board members that they should not accept nomination or election unless they are prepared to inconvenience themselves about twelve times during the year.

Each member of the Unit Board has been assigned a particular job. Jo MacDonald was extremely reluctant, in the first instance, to accept out opinion that she could become the Membership Chairman. She soon proved that our judgment was right and hers wrong as she has done an excellent job. Membership in the Unit as of June 30, was 1,407, including 1,117 paid-up members, 143 new members and 147 life members.

Bob Currie, who will be giving you a financial statement shortly, took over financial stewardship of this Unit from the previous incompetent and has been able, in the space of one year, to return the Unit to something resembling financial sanity. A bridge partner of the previous Treasurer remarked that as he was unable to add up to thirteen, let alone 52, it didn't seem reasonable to expect him to balance the financial books. We'll hear a bit more about the

finances in a few moments.

The Unit was fortunate in having two excellent secretaries, both of whom are leaving the Board and both of whom will be missed. Donna McDuff has served as Recording Secretary, taking minutes at the Board meetings and distributing them to members. In addition, she has served as our "telephone liaison officer" by phoning members to remind them of meetings, changes of locaton, etc. Margaret Lower has been our Corresponing Secretary for the past year. She drafts much of the correspondence to ACBL Head Office and to other outside agencies. In addition, she looks after the Archives of the Unit. She has done a great deal towards the organization of the annual election this year.

The most faithful member of the Unit Board - in fact she did not miss a meeting this year - is Pat Stevens. She has looked after the innumerable details related to the Sectional tournaments and has done an excellent job. Not the least of her worries has been the rising cost of hotel space. As most of you know, we have been able to, I think, improve our hotel situation by moving this coming fall to the Holiday Inn, Harbourside, where we will pay somewhat less than we were paying in Richmond for what we think are better facilities. One innovation in the Sectionals this year has been the introduction of Novice games on Friday night. These have been popular and will be continued with trophies for the winners.

Much of Helen Mitchell's enthusiasm and drive this year has been directed towards organization of the numerous special events there are sponsored by the Unit. These include the Charity Games, Olympiad Fun Games, Grand National Trials, Inter-city Trials and Inter-city Tournament.

Harvey Richer, who is not here tonight, took over the management of the monthly Unit games from Lawrence Betts who resigned from the Board last December. Since that time, the Unit games have moved to this Hotel, attendance has improved, the scoring has been facilitated by the addition of a second director and we are trying hand analysis records. We would all like our monthly Unit game to become the biggest and best in District 19 and Harvey's improvements are helping us achieve this end.

This is the second year for the IMP League. Jim McCulley organized the League this year and kept the timetable going. From all reports this was a successful event.

The Unit Board was a little apprehensive when the Nagy's left the Board and consequently gave up the management of the Matchpointer. We are fortunate that Gary Harper stepped forward and volunteered for this time-consuming and difficult job. The Matchpointer is an extremely important part of the Unit's functions as it is by this means that we can notify one another of the up-coming events and the results of previous events. The number of issues published and the number of pages per issue have been determined to a great extent by the finances of the Unit. We are currently investigating the possibility of obtaining our own duplicating equipment in order to reduce the printing costs.

Henry Smilie continues to represent us all on the Canadian Bridge Federation and on DINO. At his suggestion, we recently elected Pat Stevens as an additional Unit representative on the DINO Board.

Paula Zalkowitz has continued to operate the partnership desk in all of our tournaments. This is a difficult and delicate chore which she has carried out tactfully and with good humour. Paula will not be on the Board next year and I hope we will be able to persuade her to help out with the partnerships, anyway.

Considerable time was spent this year discussing the revisions to the By-laws. You will recall that a revised set of By-laws did not achieve the 60% majority required to pass at the last annual meeting. Subsequently, several open meetings were held and the Unit Board spent a good deal of time discussing possible changes. You have now all seen the revised set as well as the old set and a vote will be held later this evening. I certainly hope it passes as I am thoroughly sick of the By-laws per se. (It did!) Of more interest to me at present are the Regulations which the Board hopes to pass within the next several months. Our prime parliamentarian, Bob Brooks, has gone over the Unit Board minutes for many years and compiled the data required to draw up a set of Regulations to govern the activities of the Board. Once these are discussed and accepted by the Board, they will be published for you all to see. Regulations can be changed as the occasion demands by the Board of Directors, while the By-laws, as we all know, require a full open meeting of the Unit.

The Conduct and Ethics Committee is composed of non-Board members. They are a group of five members of the Unit who have agreed to investigate and make recommendations relating to complaints about conduct and ethics which involve members of this Unit or which occur at our tournaments. They have not been extremely active this year and this speaks well for the membership. I would like to thank them, however, for standing by ready to cope with these sorts of problems.

Finally, a word of thanks for the people who have assisted with the election. The results will be issued later in the meeting. The Nominating Committee was chaired by Hy Waks; the other members were Bob Brooks and Virginia McGonigle. They supplied a fine panel of nominees and I am sure that we will be pleased with the results of the election. Frank Henderson agreed once again to serve as the Returning Officer, and we thank him for his efforts.

I am sure I have forgotten many people whose activities during the year helped the Unit and I have probably also forgotten events which other Board members may have thought worth reporting. I apologize for these omissions. I would like to close by thanking you all for the honour accorded me in serving as your President for the past year. It has been an undramatic year, a year of quiet progress, and I am sure that this progress will continue during 1976-77.




